### **Fees and Expenses:**

#### **Charges :**

A non-refundable booking fee of **(\$300)** is payable to **Farm Star Equine Services** and is due with signed contract. The remaining balance of the stud fee **(\$1250)** due before first shipment. If balance of stud fee is not paid within current breeding season, and semen is not shipped, Mare Owner will forfeit booking fee and this contract will become null and void. Should more than one embryo result from breeding, mare owner must submit another contract and pay an additional Booking & Stud Fee **(\$1500)**

**Cooled Semen Expenses:** In addition to the Stud Fee, prior to the first shipment of semen, the Mare Owner must pay, in full, the Stallion Collection Fee (minimum **\$300-\$500**) and the respective Shipping Fees (FedEx fees raised to the nearest quarter). This will cover all costs associated with the semen shipping process for the first shipment of semen, including lab and handling costs, and overnight shipping process for the first shipment of semen within the United States. If additional shipments are required, costs will reflect the same protocol. Canadian FedEx shipments are an additional **\$100** per shipment. If additional shipments to Canada are required, the cost will be calculated using the same protocol.

- \* Collection days are Monday, Wednesday and Fridays from February 2<sup>nd</sup>, 2026 to July 1<sup>st</sup>, 2026.\***
- \* Cooled Semen requests must be placed the day prior to collection by 4 pm EST.\*\***
- \* Frozen Semen requests must be placed minimum of 24 hours prior to shipment.**
- \* \*\*\*Orders not cancelled by 9:00am EST on collection days will be subject to cancellation fees.\*\*\***
- \* Counter to counter shipments are not available.\***

**Equitainer:** The Mare Owner understands that the Equitainer is the property of the Stallion Owner and that the Mare Owner does not obtain ownership rights to the Equitainer by virtue this agreement. Should the Mare Owner fail to return the Equitainer to the Stallion Owner within five (5) business days after receipt, **\$300.00** shall be charged to the Mare Owner to cover the cost of the Equitainer. The cost of returning the Equitainer is the responsibility of the Mare Owner.

**Cooled Semen Containers:** The Mare Owner understands that the cooled semen container is the property of the Stallion Owner and that the Mare Owner does not obtain ownership rights to the container by virtue this agreement. Should the Mare Owner fail to return the Container to the Stallion Owner within 5 business days after receipt, **\$75.00** shall be charged to the Mare Owner

to cover the costs of the container. The cost fo returning the container is the responsibility of the Mare Owner.

**Facility Breeding Expenses:** Rehabilitation, boarding, farrier and any other expenses will be payable upon receipt of invoice or when the mare leaves the farm, whichever occurs first. Haul-in breeders must pay stud fee in full prior to hauling mare out after breeding. Mare owner is subject to all veterinary fees accrued for each breeding. Veterinary Expenses will be billed separately and must be paid directly to FARM STAR EQUINE SERVICES.

**Billing:** Bills are due and payable in full upon receipt and/or prior to the horse leaving FARM STAR EQUINE SERVICES. Any balance remaining unpaid after thirty days from the billing date shall bear interest at the rate of 2 % per month from the date billed to the date payment if received. In the event that the account is not paid within 45 days from the date of the monthly statement, the stallion owner may refuse to palpate, tease or breed the mare. PayPal, Venmo, Square, and Visa and MasterCard are accepted, but there is a 4.0 % charge for card.

### **Mare Registration**

A COPY OF THE MARE REGISTRATION PAPERS, WITH CURRENT OWNER LISTED OR LEASE AGREEMENT MUST ACCOMPANY CONTRACT. THE OWNER RECORDED ON THE REGISTRATION CERTIFICATE WILL BE RECORDED ON THE STALLION BREEDING REPORT.

### **Farm Breeders Condition and Treatment:**

The Mare Owner represents and warrants to the Stallion Owner that the Mare is in sound breeding condition, is free from infection and disease ( Negative Culture). That the Mare tested negative on an EIA (Coggins) Test performed within twelve (12) months prior to the date of this agreement. Prior to arrival at the breeding farm, mare must have a veterinary health certificate including deworming, and immunization records, current negative EIA test, and negative culture.

If these documents are not presented upon the mare's arrival, the Stallion Owner shall have the attending veterinarian make proper tests and evaluations at the mare owner's expense.

Breeding Method of on farm mares is at the sole discretion of the Stallion Owner and/or the attending veterinarian. The Stallion owner agrees to diligently try to settle the mare, however if the mare should not settle, the Stallion Owner/veterinarian shall be held harmless.

A Mare deemed not in sound breeding condition by the attending veterinarian shall not be bred. In such a case, the mare owner may substitute another mare within the same breeding season.

Should any foal which is born to the mare, pursuant to this contract, not stand and suckle, the Owner shall be entitled to a re-breed the following year only for this mare.

**THIS RE-BREED SHALL APPLY ONLY IF**

**THE IS NOTIFIED WITHIN ONE (1) WEEK OF THE DEATH OF THE FOAL. THIS NOTIFICATION MUST BE ACCOMPANIED BY A STATEMENT FROM A LICENSED VETERINARIAN, STATING THE DATE AND CAUSE OF DEATH.**

Sole liability and obligation for any foal that is born to the mare, but does not stand and suckle, shall be the granting of the re-breed. Such breeding shall apply to the Farm Fee and associated veterinary expenses only and only to the season immediately following the season set forth in this contract. If the mare proves not to be in foal or if the foal does not stand and suckle, Stallion Owner has the option to re-breed the mare the following year only. All re-breeds must pay a re- breed fee of

**\$500 (no booking fee)**

**Binding and Entire Agreement:** This contract, when signed by the Mare Owner and the Stallion Owner and accompanied by payment of breeding farm fee, shall be a binding contract on both parties on the above terms and

conditions. This contract constitutes the entire agreement between the parties concerning the breeding of the Mare and the Stallion.

**Counterparts and Facsimiles:** This contract may be executed in any number of counterparts which, taken together, shall be considered as single contract, and may be transmitted via facsimile, with facsimile signatures binding the part so signing.
